NOTICE 6/2020

Considering the Resolution of the Council of Ministers n.^{er}40-A/2020, May 29th, which establishes exceptional and temporary measures to deal with SARS-CoV-2 epidemics and COVID-19 disease, within the scope of the state of calamity declared to the entire Portuguese territory.

Considering the Resolution of the Council of Ministers n.^{er} 10-B/2020, March 16th, changed and republished by the Resolution of the Council of Ministers n.^{er} 34-A/2020, May 13th.

Considering the declaration of the state of public calamity by the Regional Government of the Azores, through the Resolution of the Council of the Government n.^{er} 141/2020, May 18th, regulated by the Resolution of the Council of Government n.^{er} 152/2020, May 28th, and also the Resolution of the Council of Government n.^{er} 159/2020, May 29th, in what regards the applicability of entry procedures to yachtsmen.

Under the empowerment of n.^{er} 1 of article 13th of the Decree-Law n.^{er} 44/2002, March 2nd, I determine the following:


1. For the maritime connections coming from outside the Azores, when the last port of call was not in Portuguese territory, small crafts docking are prohibited, except in cases involving safety of navigation, vital equipment breakdown, indispensable logistics and health/medical reasons.
People disembarkation are also prohibited, unless the exception criteria referred in n.^{er} 5 of the Resolution of the Council of Ministers n.^{er} 10-B/2020, March, 16th, and with previous Health Authority permission.
2. For the maritime connections coming from outside the Azores, when the last port of call was in Portuguese territory, disembarkation is authorized following the procedures established by the Resolution of the Council of Government n.^{er} 152/2020, May 28th, with the necessary adaptation, namely that the time of the passage is considered as quarantine time, in the event that such a procedure is adopted, and the vessel is considered a residence.
3. Maritime connections between Azorean Islands are authorized and do not require previous authorization of the Health Authority. However, crews and passengers that have arrived from outside the Azores must comply with the measures established in n.^{er} 9 of the Resolution of the Council of Government n.^o 152/2020, May 28th.

4. Situations of non-compliance with the provisions of this Notice will be regulated and sanctioned under the terms defined in line b), of n.º 2, of article 4th, of Decree-Law n.º 45/2002, March 2nd.

This notice cancels Notice 1/20, March 13nd.
